6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13-02-2025 13:00 at the office of Yasodhara Rural Municipality, Kapilvastu Lumbini Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 25000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[02715229661] at [Siddhartha Bank Ltd. , Yashodhara Rural Municipality-7, Maryadpur] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
