	Without limitation on the generality of the foregoing, and unless stated otherwise in the Data Sheet, the Consultant shall not be hired under the circumstances set forth below:
a. - 13.1.2 If the amendment is substantial, the Client may extend the proposal submission deadline to give the shortlisted Consultants reasonable time to take an amendment into account in their Proposals.
- 13.1.3 The Consultant may submit a modified Proposal or a modification to any part of it at any time prior to the proposal submission deadline. No modifications to the Technical or Financial Proposal shall be accepted after the deadline.

14. Preparation of Proposals – Specific Considerations

- 14.1 While preparing the Proposal, the Consultant must give particular attention to the following:

 - (iv) "obstructive practice" means:
 - (aa)deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a GoN/DP investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (bb) acts intended to materially impede the exercise of the GoN's/DP's inspection and audit rights provided for under Clause GCC 25.2.
- will reject a proposal for award if it determines that the consultant recommended for award has engaged in corrupt or fraudulent activities in competing for the contract in question;
- will cancel the consultant's contract if it at any time determines that corrupt or fraudulent practices were engaged in by representatives of the consultant or the Client during the selection process or the execution of that contract;
- d. will blackist a consultant for a stated period of time, to be awarded a contract if it at any time determines that the consultant has engaged in corrupt or fraudulent practices in competing for, or in executing, a contract; and
- e. will have the right to require that, a provision be included requiring consultants to permit the Client to inspect their accounts and records relating to the performance of the contract and to have them audited by auditors appointed by the Client.

१. पृष्ठभूमि

कर्णाली प्रदेशका अधिकांश जनताको मुख्य पेशा कृषि क्षेत्र रहि आएको छ । विविधतायुक्त कृषि क्षेत्रले हाम्रो जीविकोपार्जनलाई दिगो बनाउनुका साथै वस्तु र सेवाहरू लगायत अतिरिक्त रोजगारी र आयं उपलब्ध गराएको छ । जलवायु परिवर्तन र यससँग सम्बन्धित प्रांकृतिक प्रकोपको सामना गर्दे खाद्य तथा पोषण सुरक्षा, सम्वृद्धि र समानुकुलन निर्माणमा यस क्षेत्रको योगदान सर्वोपिर रहेको छ । फलस्वरूप, दिगो रूपमा जीविकोपार्जनलाई सहयोग गरी यसलाई बढावा दिन समेत कृषि क्षेत्रको योजनावद्ध रुपमा नीति, रणनीति र योजना तर्जुमा गर्नु आवश्यक छ । निर्वाहमुखि उत्पादन प्रणालीबाट व्यवसायिकरणमा रुपान्तरण गर्न आधुनिक कृषि प्रविधि, ज्ञान र औजारहरुको प्रयोग गरी उत्पादकत्व र उत्पादन बढाउनु समेत जरुरी छ । हाम्रो उच्च प्राथमिकता कृषक समुदायको जीविकोपार्जनमा सुधार, कृषिमा आधारित उचोगहरूको प्रवद्धन, रोजगारी तथा आयका लागि अवसरहरुको सृजना गरी यस प्रदेशमा खाद्य तथा पोषण सुरक्षामा सुधारका साथै गरिबी उन्मूलन गर्ने उपायहरू खोजी गर्नुमा केन्द्रित रहेको छ ।

नेपालको संविधान २०७२ को मर्म र भावना अनुरुप एकीकृत दृष्टिकोण र कसैलाई पछि नछोड्ने (No one leaving behind) सिद्धान्तका माध्यमबाट मुलुकमा रुपान्तरणकारी परिवर्तनका लागि बलियो राष्ट्रिय प्रतिबद्धता सिंहतको नेपाल सरकारको दिगो विकास लक्ष्य सन २०३० को एजेण्डालाई प्रदेश सरकारले आत्मसात गरेको छ। त्यसैगरी पन्धौं आवधिक योजनाले कृषि क्षेत्रको उत्पादकत्व एवं नाफा बढाउने र व्यवसायीकरण गर्ने लक्ष्य राखेको छ। साथै आर्थिक वृद्धि गर्ने र सुधारिएको जीविकोपार्जन तथा खाद्य र पोषण सुरक्षामा योगदान पुयाउँदै खाद्य संप्रभुताको नेतृत्व गर्ने कृषि विकास रणनीति (२०१५ - २०३५) ले आत्मिनर्भर, दिगो, प्रतिस्पर्धात्मक र समावेशी कृषि क्षेत्रको परिकल्पना गरेको छ।

कर्णाली प्रदेश प्रदेश कृषि आनुवंशिक स्रोत र जैविक विविधताले धनी प्रदेशहरु मध्येको एक हो । कुल गार्हस्थ्य उत्पादनमा करिब एक तीहाइ भन्दा बढी हिस्सा योगदान दिने र ८० प्रतिशत भन्दा बढी रोजगारी सिर्जना गर्ने यस प्रदेशको मुख्य आधार कृषि क्षेत्र हो । यो क्षेत्रमा अत्यिधक विविधता हुनाका साथै हाम्रो जीविकोपार्जनको लागि खाद्य

र पोषण, रोजगारी र आम्दानीको प्रमुख स्रोत पिन हो । थप रोजग़ारी र आम्दानी सृजना गरी प्रदेशका जनताको जीविकोपार्जनमा दिगो रूपमा सुधार गर्ने उद्देश्यले प्रदेश सरकारले कृषि क्षेत्रलाई प्राथमिकता दिएको छ ।

कृषि पेशा अधिकांश नेपालीको जिविकोपार्जन र आम्दानीको मूख्य स्रोत, खाद्य सुरक्षाको आधार स्तम्भ र गरिवी निवारणको प्रमुख क्षेत्रको रुपमा रहेको छ। बदलिँदो राजनैतिक सन्दर्भ, कृषि क्षेत्रमा आएको पविर्तन र यस रणीनीतिले सिर्जना गरेको अनुकुल वातावरणले सरकारी, निजी र सहकारी क्षेत्रहरुलाई लगानी गर्न थप प्रेरित गर्ने छ। साथै यस योजनाले यस अधिका कृषि क्षेत्रसँग सम्बन्धित नीति, रणनीति, आवधिक योजनामा भएका कमी, कमजोरी सुधार तथा यसका सफल अभ्यासहरुलाई समाहित गरी कृषि क्षेत्रको मार्ग दर्शक नीतिको रुपमा रहने कुरामा कुनै दुविधा छैन।

नेपालको संविधानले खाद्य सम्बन्धि अधिकारलाई मौलिक हकका रूपमा प्रत्याभूत गरेको छ। यसै सन्दर्भमा विभिन्न कारणले उत्पन्न हुनसक्ने खाद्य तथा पोषण सङ्कटको अवस्थालाई अध्यनजर गर्दै प्रमुख खाद्यान्न, फलफूल, तरकारी र माछामासु उत्पादनमा आत्मिनर्भरताका लागि यस गाउँपालिकामा पिन कृषिमा नीतिगत, संरचनागत र संस्थागत सुधारको आवश्यकता छ। गाउँपालिकालाई खाद्य सम्प्रभु तुल्याजन र गाउँपालिकाको स्वाधीन अर्थतन्त्रको विकास गर्न कृषि क्षेत्रमां उल्लेख्य मात्रामा लगानी बढाउन आवश्यक छ। नेपालको संविधानको आधिकार सूची तथा कृषि क्षेत्रको समग्र विकासका लागि मार्गचित्रको रूपमा रहेको कृषि विकास रणनीति (सन् २०१४ - २०३४) र दिगो विकास लक्ष्यलाई गाउँपालिकामा कृषि क्षेत्रको विकासका लागि मार्गदर्शनको रूपमा लिइएको छ। उक्त रणनीतिले कृषि तथा पशुपक्षीजन्य उत्पादनको व्यवसायीकरण र विविधीकरण गरी यस क्षेत्रलाई प्रतिस्पर्धी बनाउन जोड दिएको छ। यसैगरी दिगो विकास लक्ष्यले लिएको भोकमरीको अन्त्य गर्ने, खाँच सुरक्षा तथा पोषण सुनिश्चित गर्ने तथा दिगो कृषिको प्रवर्द्धन गर्ने लक्ष्य हासिल गर्ने गरी यस क्षेत्रमा स्रोत र साधनको परिचालन गर्नुपर्ने छ। विशेषतः कृषि क्षेत्रको व्यवसायीकरणका माध्यमबाट थप रोजगारी सिर्जना गरी आयआर्जन तथा गरीकी निवारण समेत सम्बोधन गर्नुपर्ने छ। यस गाउँपालिकाको लगानीलाई कृषि क्षेत्रको समग्र विकासमा परिचालन गर्न, तर्जमा गर्न लागेको कृषि योजनाले मदत गर्ने छ।

नेपालको संविधान र संघीय कानूनले निर्दिष्ट गरे वमोजिम कर्णाली प्रदेश अन्तर्गत कर्पिलवस्तु जिल्लाको नरहरीनाथ गाउँपालिकाको आफ्नै प्रयासमा यहाँका ग्रामीण समुदायको समृद्धिको प्रमुख आधारको रुपमा रहेको कृषि र पशुपालन क्षेत्रको विकास मार्फत खाद्य तथा पोषण सुरक्षा र दिगो आयआर्जनका उपायहरु अवलम्बन गरी रोजगारीका अवसर सृजना गर्ने तर्फ केन्द्रित छ । यस तर्फ अग्रसर हुनका लागि दीर्घकालीन सोच, निश्चित समयसिमा भित्र हाँसिल गर्न सिकने लक्ष, स्पष्ट उद्देश्य, लक्षित कार्यकम, अपेक्षित उपलब्धी तथा प्रतिफल हाँसिल गर्न आवश्यक पर्ने कार्यनीती तथा प्राथमिकताहरूको पहिचान र यथार्थमा आधारित नरहरीनाथ गाउँपालिकाको कृषि विकास योजना तर्जुमा गर्नको लागि प्रस्ताव माग गर्नुपंर्ने छ ।
